SOLIDARITY AND UASA- (FURTHER RECTIFICATION OF CIRCULAR DATED 23-3-17)**


A Settlement Agreement for the period 1 July 2017 to 30 June 2020 was signed by SEIFSA, MEWUSA, NUMSA, SAEWA, SOLIDARITY and UASA at the offices of the Council on 23 August 2017.

Details of the wage increases have been set out in a separate Circular which has already been forwarded to you and posted on the MEIBC website.

The increases are only applicable to the SEIFSA associations that are party to the agreement and not applicable to Consolidated Employers Organization (CEO), National Employers Association of South Africa (NEASA), South African Engineers and Founder Association (SAEFA) and Plastic Convertors Association (PCA).

Wage exemption applications by Seifsa associations must be submitted within 30 days of signing of the Settlement Agreement i.e. by no later than 22 September 2017.
